To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis Statutes, specifically a proposed tax levy which would exceed the allowable town levy for 2016 by 8.104 percent which would be a dollar increase of \$20,240.00.
