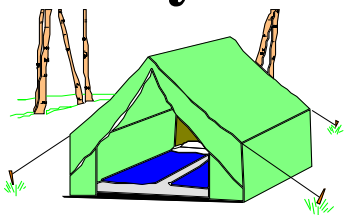


# Welcome to Nugget Lake County Park



## 2018 Camping Information

### FACILITIES

- 752 acres of semi-wilderness
- Scenic 116 acre lake (Electric trolling motors only) Fishing pier
- Campground with 50 electrical sites and 5 camping cabins
- Camping cabins have heat & air conditioning
- Modern comfort station with hot showers and flush toilets
- Nature programs / movies offered on weekends or by appointment
- Seven miles of groomed hiking and cross-country ski trails
- Boat, canoe and kayak rentals
- Picnic area with two reservable shelters
- Two large play systems
- Drinking water fill station
- Dump station
- **NO SWIMMING BEACH**

### INFORMATION

Nugget Lake County Park is open for visitors year round. The picnic area hours are 5 a.m. - 9 p.m. The campground is typically open April 1 thru November 30, weather dependent.

#### **Seasonal office hours:**

(Memorial Day - Labor Day)

8 a.m. to 9 p.m. Sunday - Thursday

8 a.m. to 10:30 p.m. Friday and Saturday

### CAMPING REGULATIONS

**Quiet hours are 11 p.m. to 6 a.m.**

**Loud activity and audio equipment prohibited during these hours.** Violators will be **prosecuted**. Emergencies and noise complaints should be reported to the park office. If rangers are not available at the office, please call the Pierce County Sheriff's Department at (715) 273-5051 or 911.

- Alcohol abuse is strictly prohibited.
- Camping is allowed on designated sites only.
- Camping units must remain within the campsite boundaries.
- **Only one family or camping unit allowed per site.**
- Camping permits expire 3 p.m.
- Cabin camping permits expire at noon.
- No camper shall move to another site without prior approval.
- Fires are allowed in fire-rings only.
- Additional park regulations located in the park office.

### FEE SCHEDULE

Park fees are collected year-round by park employees, or at the self-registration station. An entrance permit is required for all motorized vehicles entering Nugget Lake County Park. Camping fees are paid in addition to entrance fees. Canoe and boat rentals are available on a first come first serve basis.

Daily entrance permit (per vehicle per day).....	\$ 5
Annual entrance permit .....	\$ 30
Camping cabin .....	\$ 65
Camping (All sites are electric) .....	\$ 22
Camping reservation fee.....	\$ 6
Firewood bundle .....	\$ 5
Canoe/Boat/Kayak Rentals.....	\$8 1 <sup>st</sup> hr./\$5 addt.hrs.

- Fishing licenses, bait, and ice are available at the park office.
- A \$6 non-refundable camping reservation fee applies to **all** camping reservations made.
- Dogs are allowed if kept **quiet**, attended and on leash.
