

**RESOLUTION NO. 2011-1**

**RESOLUTION TO ADJUST THE WARD BOUNDARIES  
IN THE TOWN OF OAK GROVE – PIERCE COUNTY**

**WHEREAS**, per WI Stats. 59.10(3)(b)(1) Pierce County has submitted a tentative plan to the Town of Oak Grove for the creation of county supervisory districts that are substantially equal in population based on the 2010 census; and

**WHEREAS**, Wis. Stats. 5.15(1) provides for the division of a municipality into wards; and

**WHEREAS**, Wis. Stats 5:15(2)(b) provides that population of a ward shall not contain more than 1,000 inhabitants; and

**WHEREAS**, Wis. Stats 5:15(4)(a) states the division resolution shall number all wards in the municipality beginning with number one, and shall describe the boundaries of each ward; and

**THEREFORE BE IT RESOLVED**, that Ward 1 of the Town of Oak Grove be that part lying northerly of State Rd 35 and westerly of the following described reference line: beginning at the intersection of State Road 35 and County Road QQ, thence northerly along County Road QQ to 1090<sup>th</sup> Street; thence easterly and northerly along 1090<sup>th</sup> Street to US Highway 10; thence northwesterly along US Highway 10 to County Road QQ; thence northerly along said County Road QQ to the Town line, said area to be part of Supervisory District No. 15; and the designated polling place shall be the Town Hall; and

**BE IT FURTHER RESOLVED**, that Ward 2 of the Town of Oak Grove be that part lying southerly and southwesterly of State Road 35 and east of the City of Prescott, said area to be part of Supervisory District No. 16; and the designated polling place shall be the Town Hall; and

**BE IT FURTHER RESOLVED**, that Ward 3 of the Town of Oak Grove be part lying northerly and easterly of State Road 35 and easterly of the following described reference line: Commencing at the intersection of State Road 35 and County Road QQ, thence northerly along County Road QQ to 1090<sup>th</sup> Street, thence easterly and northerly along 1090<sup>th</sup> Street to US Highway 10; thence northwesterly along US Highway 10 to County Road QQ, thence northerly along County Road QQ to Town line and end of reference line, said area to be part of Supervisory District No. 13; and the designated polling place shall be the Town Hall; and

**BE IT FURTHER RESOLVED**, that Wards 1, 2, and 3 be combined for reporting election results, except for the election of County Board Supervisors; and

**BE IT FURTHER RESOLVED** that the designated polling place is the Town Hall.
