Emergency Management updates/Training-Radiation exercise was completed this week and last week. Christine would like to do a larger scale drill in Ellsworth next year.

Public Health Updates/training opportunities-AZ updated on COVID and Monkey Pox. Recent increases in COVID cases. Pierce County remains in the yellow designation. PC is still providing COVID vaccinations. Anticipating that there will be a seasonal COVID boosters. Prepared to resume mass vaccinations if indicated. Anticipating updated CDC quarantine guidance. Regarding Monkey Pox, it has been declared a national health emergency. Cases in MN and WI have been reported. Also reported to be community spread. It is spread mostly via skin-to-skin transmission. Also noted the possibility of fomite spread and possibility of droplet spread. Pierce County and Eau Claire County are the only Western WI counties with available vaccine. We do have PUI in the area but no confirmed cases. We may also be getting a new type of fit testing machine in the area. More updates to come.

Dispatch Updates-Christine reported that dispatch is back to fully staffed. Eric VanHorn was recently hired. Recently had some issues with IaR. For those with concerns please contact the IaR rep. Colin talked with Tyler from IaR. Appears that there is some issue with settings regarding verbiage to protect information. Colin will report back if his 'fix' is working.

Education Updates -Ellsworth providing (5) \$1,000 scholarships. One lives in El Paso and one near Elmwood. Collin reached out to Katy Frey at WEMSA to see if they can help with accommodating smaller numbers of students or people that need remote learning. Hot Topics Conference in November. Contact Lifequest if interested. Jessi would like to start talking about 2023 PC EMS Conference. Will be placed on the agenda for Oct. meeting.

Sheriff's Department Updates-Struggling with staffing. 3 open patrol positions. Jail is also short on staff but looking forward to new personnel. PCSO has new body cameras.
