1) Meeting Convened

The Pierce County Building Committee met in the County Board Room of the Pierce County Courthouse, Ellsworth, WI. Chairman Dan Reis called the meeting to order at 4:01 p.m.

1a) Those Present

A quorum was established acknowledging 4 members present; 1 excused.

1b) Public Comment

None

2) Agenda Adopted

Motion by D. Auckland/J. Kosin to adopt agenda as presented; motion carried unanimously.

3) Minutes Approved

Motion by S. Bjork/J. Kosin to approve minutes of the Feb. 11th, 2020 meeting; motion carried unanimously.

4) Discuss / Take action on the equipment & services trade with the River Falls FFA Alumni

A. Webb explained that the group would like to do a trade in service. They would provide up to 30 radios & additional staff for Pierce County's tractor pull & fair events, in return for the use of 20 picnic tables during their annual event. She further explained that a written agreement could be drafted that assured if tables were damaged they would be replaced & that pick up & delivery of tables would be the responsibility of the FFA. Motion by S. Bjork/D. Auckland to approve the use of picnic tables by River Falls FFA in return for the use of their radios & additional personnel help during events; motion carried unanimously.

5) Discuss / Take action on the Cheese Curd Festival using the Campus Parking lots during their festival

J. Forss stated the group makes this request every year & there have been no major issues with their usage of the parking lots. Motion by D. Auckland/S. Bjork to approve the usage of campus parking lots for the Cheese Curd Festival event; motion carried unanimously.

6) Discuss space needs

J. Forss indicated that there was nothing new to report at this time.

7) Discuss Annex and Blue Building projects progress

J. Forss indicated that Market & Johnson anticipated receiving bids for Blue Building project by March 17th. Also that blue prints are being reviewed & plans drafted for the Annex project. No action taken.

8) Discuss / Take action on hiring the Braun Intertec Corp. to do a structural assessment for the Seyforth Building

J. Forss explained that Market & Johnson recommended this company to do the assessment that was desired. This would answer the questions being asked about the roof & how it can be repaired. Supervisor J. Kosin asked who was being contracted Market & Johnson or Braun. J. Forss believed that to be Braun. Motion by S. Bjork/D. Auckland to approve Braun Intertec Corp. to perform structural survey on Seyforth Building in an amount not to exceed \$4005.00; motion carried unanimously.

9) Discuss / Take action on Round Barn foundation work bids

M. Kelly explained that one third of the foundation work has been done & this bid was for a second one third. He added that many concrete contractors were not interested in bidding this project, but that Plumber Concrete agreed to assist the County in finishing the project. The bids were as follows: Plumber Concrete in the amount of \$24,950; Cities Masonry Restoration in the amount of \$63,750. M. Kelly concluded stating funds for the project were anticipated in the 2020 Budget. Motion by S. Bjork/J. Kosin to approve bid from Plumber Concrete for Round Barn foundation work in the amount of \$24,950; motion carried unanimously.

10) Discuss / Take action on Rabbit/Poultry Building roof material bids

M. Kelly explained he obtained three bids for the building materials needed to complete the project for this building. The bids were as follows: Brenner Lumber for \$3,541.02; ABC Lumber for \$3,544.88; & Menards for \$3,617.70. Motion by D. Auckland/J. Kosin to approve bid from Brenner Lumber in the amount of \$3,541.02; motion carried unanimously.

11) Discuss / Take action on bids for bleacher repair parts

M. Kelly explained that some of the existing bleachers have been in need of repair. He indicated that the company that manufactured these bleachers is no longer in business but he was able to find replacement parts at a cost of \$1,481.60. He added that the majority of the funds could come from the bleacher account & that the rest could come from the Fair Dept. repair & maintenance expense account. Motion by J. Kosin/S. Bjork to approve purchase of repair parts for existing bleachers; motion carried unanimously.

12) Discuss / Take action on Maintenance Budget overages

J. Forss explained that the majority of the overages occurred in line items for Professional Services & Utility Services, such as electricity & sewer/water. He added that cost for those items in a new facility were difficult to estimate. He informed Committee that the overall budget deficit for the 2019 Maintenance Budget was \$16,162.29 & that funds would need to be requested to cover those deficits. Motion by D. Reis/S. Bjork to acknowledge deficit in 2019 Maintenance Dept. Budget in the amount of \$16,162.29. Also to make formal request to Finance & Personnel Committee requesting this deficit be addressed with funds from the Contingency Fund; motion carried unanimously.

13) Discuss / Take action on HVAC Service Agreements with TRANE

J. Forss indicated that he had received a price on service agreements with Trane to service the HVAC equipment at the Courthouse, PCOB, & Law Enforcement Facility. He added that they have provided the service in the past & have been very good & reliable. Motion by S. Bjork/D. Auckland to approve a one year service contract with Trane, contingent upon review by Corp Counsel, in the amount of \$37,869; motion carried unanimously.

14) Fair Groundskeeper report

M. Kelly submitted written report & gave brief oral review of monthly activities that was accepted by the

Committee.

15) Maintenance Supervisor report

J. Forss submitted written report of monthly activities that was accepted by the Committee. He added that the Dept. worked on the new fitness room to move it alone a little quicker.

16) Future Agenda Items

- None at this time

17) Next Meeting Date

Next regular meeting set for Apr. 14th, 2020 at 4:00 p.m.; County Board Room.

#7 AC unit for the IS server room – The IS Departments server room, located in PCOB, main air conditioner unit is currently non-functioning and needs to be replaced. This unit is an independent unit from the rest of PCOBs HVAC system and was originally installed late 2008 or early 2009 and runs year round as needed. This unit has had several breakdowns over the last few years and has been kind of a money pit. Sometime late October or early November is the last that this unit has run. 2 large window air conditioners that Maintenance permanently installed in that room for emergency backup have been carrying the cooling load for this rooms cooling needs. The cooling that comes from the buildings HVAC system only maintains a suitable cooling level in that room for a couple of hours if the main AC unit shuts down for whatever reason. Most of the problems have been with the compressor part of the unit that sits outside. When this last breakdown happened the compressor was the first thing that was found to be wrong. It was cheaper to have a new compressor installed than a whole new unit so I had that replaced. A leaking tank and a bad valve followed. It is hard to tell for sure which problem happened first that caused the chain of failures. These items were replaced and the unit still will not run as it should. The HVAC Tech the TRANE company that has worked on the unit the most has told me that do to the age of the unit going any farther with trying to repair it would only be throw more money away. I meet with my Trane rep and one of Trane's engineers and we came up with a plan for a replacement unit. The current AC unit has a blower mounted above the suspended ceiling of the server room and is ducted into the room using ceiling vents with the compressor unit sitting outside. The new unit would utilize a wall mounted fan unit with the compressor unit being mounted in the attic of PCOB. This system is also built with the needed smarts in that would allow it to be tied to the buildings automation system similar as we did for the new jail kitchen. The total estimate from TRANE for this project is \$12,732.00. Currently the notification of a problem in that room is if someone walks in and finds it warm or hears the beep that the thermostat makes if there is a problem. In the Building Outlay between 2 Campus Improvement line items and with some funds from the Electrical Line item there would be funds to cover this project. I would suggest a motion to continue with this project.

#8 Seyforth Building Roof – At our last Building Committee meeting I was directed to have the Braun Intertec Company analyze the roof to make sure it was structurally sound to make changes to it and also to have them determine if what our proposed plan for more insulation to the roof to help stop condensation on the inside of the building was the best option.

Braun did there analyzation of the roof and found that it was plenty sound enough to remove existing roofing material and insulation down to the main roof deck, then rebuild it up with new materials. However their insulating suggestion is different than the one formally proposed. The first thought was to take the roof down to the main deck and then build it back up by standing 2x4 nailers on their edge then spraying 3" of foam between the nailers topped off a ½" of decking and shingle. Braun's recommendation is to use 3 layers of 1 ½" foam board layered in different each layer with 2x4 nailers laid flat in the middle layer with all of it being sandwiched to the main deck with new sheeting and shingles. Braun feels that their design will give more R-Value and seal the roof up better than the spray foam option. Adding this extra depth to the roof will mean that the fascia boards and trim will have to be made bigger as this new roof design will add more than 2" of depth to the roof structure. I had Bruce Andrews Seamless Gutters figure an estimate for this insulation design. They came back with a price of \$45,152.50. The 1st quote for the spray foam was \$40,155.00. So just to recap the whole project, the insurance company will cover the cost to reshingle the roof just as it is now and the roofers already have a signed contract to put the new shingles on. The \$45,152.50 would require additional funding. There are funds available in the Building Outlay under Fairgrounds Improvements that could cover the cost of this project. There is also the option to just have the roof redone as it currently sits.

I would suggest a motion to have me put this insulation project out for bids and to bring the results back to a future meeting for action.

#9 – Silver Barn Structure – The Silver barn has poles that are tipping out at the tops causing the some of the rafters to pull apart in the middle making sags in the roof and portions of the side walls to bow out. Fairgrounds Keeper Kelly brought this issue to the Building Committee back in the June meeting of 2018 in which he also brought forth a price to put band-aids on the rafters to help keep them from pulling apart any further until at a future time in which the building had any roofing work done to it. This passed and the band-aids were placed. Now due to the hail storm in the fall of 2018 the building is going to have new roof and sidewall metal put on it. This is the opportune time to get the structure of the building put back where it should be. Quotes for this project were not sought out at the time when funds were being asked to supplement the insurance monies for this build because of the uncertainty that those funds would be made available so we didn't want to waste anybody's time figuring quotes. That coupled with there are funds in a Fairgrounds Improvements line item that could cover the cost of the project.

Then we rolled into this Pandemic where no meetings were being held. The time for the new roof and siding is very near. Bruce Andrews Seamless Gutters has given a quote of \$7,556.00 for these repairs.

I would suggest a motion to put this structural repair project out for bids and bring it back to a future meeting.

#10 – Rabbit/Poultry Barn Roof – Back in March 2019 Building Committee Meeting, Fairgrounds Keeper Kelly brought to you plans and ideas for an addition to be added onto the building with the Cattle Association raising funds for the materials and part of the labor with the fair staff doing the other part of the labor. Long story short, the addition was completed minus the metal roofing material. There are approximately \$1,500 left of the funds raised by the Cattle Association to put towards the roofing material. The Roofing Company doing the other roofs were asked to give a price for just the material that would match the other parts of the building's roof already scheduled to be done and also a price if they put the material on. Well I am not sure where the communications got lost or misinterpreted, I will take the blame though, but the portion of roof in question got put on with no cost estimates and now we have a bill for about \$4,836.00 once the donation money is deducted. In the bigger picture of the whole roofing project, there are a couple of roofs that the roofers did that were not on the list for replacement that didn't cost the County any money. The roof on the round barn milk house got replaced when the rest of the round barn got done because just guessing they thought it was part of the round barn and thought it should match and one of the small electrical buildings because they had left over material from a different roof. The Tan Bathrooms they upgraded from shingles to metal at no cost because this building sits across from where they set up their fair booth and they want be able to point at it when customers are there visiting the booth. So with that all in mind, 4 options that come to my mind for this are, pay the bill with the money coming from the Fairgrounds Improvement Outlay funds, not pay the bill and have it become a legal matter, have them remove the roofing in question and start over with quotes or some option that comes from the meeting discussion.

#11 – Excess Equipment For Auction – The items from the old jail kitchen and office equipment left from when the Sheriff's Dept. moved from the Annex coupled with other odds and ends were sold on the WI Surplus Online Auction as directed by the Building Committee in a previous meeting. The funds from the kitchen equipment were given to the Sheriff and the other funds went to the general fund. Anyway, there are a few other items between the Maintenance and Fairgrounds Departments that are no longer of use and take up space that

I would like to put on another auction. Some of the bigger items being: a front end loader attachment and bucket from an old tractor used in the fairgrounds, an old walk behind John Deere snow blower that we can't get started bought in 1993, some pieces of old rubber roofing bought on an auction to be used for landscaping fabric under rocks by the Blue Building and maybe a few other smaller items sitting around. I would suggest a motion to put these items on a WI Surplus Online Auction with the funds generated going to the General Funds.

Braun Intertec Corporation is pleased to provide this report to summarize the findings from our Structural Review and Assessment of the existing roof structure and its proposed alterations for the Seyforth Building located in Ellsworth, Wisconsin.

Background

The Pierce County Fair Board is looking to improve the overall insulating performance and capabilities for one of the existing buildings located within the Pierce County Fair Grounds. The building structure is constructed using vaulted glulam frames that serve as the main roof supporting structural framing element. Additional structural wood framing elements found throughout the roof area of the building are supported by and framed to the vaulted glulam frames. This includes the individual glulam beam sections and roof enclosing wood decking. Currently, a buildup of condensation has been evident along the underside of the roof structure and specifically within the existing light fixtures found throughout the building. It is presumed that the infiltration of moisture is caused by the limited presence of insulation throughout the roof area in combination with the fact that the main light fixtures are within the profile of the makeup of the roof structure.

The Piece County Fair Board is reviewing the feasibility of placing new roofing and insulation along the topside of the existing roof structure in an attempt to mitigate any further infiltration of moisture through the roof section. Braun Intertec has been retained to perform a structural assessment of the existing roof structure and its ability to support proposed roofing modifications along with providing commentary on the proper procedure for replacing and modifying the roofing if the structure is deemed feasible to support the new loads.

Observations and Comments

The following information was obtained through a site visit conducted on April 6, 2020 by Denis Mikulic of Braun Intertec:

- a. For reference purposes throughout this report, the building wall elevation that faces Midway Ave. will be considered the north elevation for the overall building structure. Therefore, the west wall elevation of the building faces and extends parallel to the main roadway – Hwy 65/N. Maple St.
- b. The building is comprised of a single floor elevation that is currently used for two primary purposes and occupancies. In plan, the building is rectangular in shape and has a total building footprint that measures out to be approximately 54 feet in width along the east/west directions and 116 feet in total length along the north/south directional axis. Approximately 60 percent of the total building footprint area is used as an open space assembly/gathering area while the remaining 40 percent of the building is used for office space purposes *[Photograph 1]*.
- c. The vaulted glulam frame sections serve as the primary load-carrying structural framing element for the overall roof framing area of the building. They span transverse to the buildings longitudinal length in the east/west directions along the entirety of the buildings total width. A total of eight (8) vaulted glulam frames were identified during the onsite assessment, this included five (5) within the open space assembly/gathering area and three (3) in the office area of the building. They are evenly spaced throughout the roof area at a measured spacing of approximately 15 feet 6 inches on center. The total depth of the glulam frames varies along the length of the supporting wood element as it projects towards the peak of the building's roof structure. Based on the original client provided construction documents the vaulted glulam sections have a total height of approximately 18 feet 9 inches measured from the top of the finished interior floor surface. Therefore, the roof peak is measured at approximately the same building height elevation.
- d. Field measurements taken at multiple points along the vaulted glulam frames indicate that the wood framing element tappers down in total depth as it projects towards the roof peak. Field measurements taken at the base and near the curvature radius for the framing element indicate that the wood framing member is comprised of 32 individual laminated plies that give the section a total depth of approximately 24 inches and a total width of 5 inches. The 5 inch width is consistent along the entire length of the framing member and at both ends of the building structure. Field measurements were taken intermittently every third point including at the roof peak, based on those field measurements the following cross-sectional make up was determined at each point:
 - Near the Curvature Radius: 5-inches by 24-inches
 - One-Third Point: 5-inches by 20-inches
 - Two-Third Point: 5-inches by 18-inches
 - Roof Peak: 5-inches by 16.375-inches

Based on those field measurements it was determined that the wood framing members cross-sectional depth is reduced at a slope of approximately 2 percent as it projects diagonally toward the roof peak for the overall building structure [*Photograph 2*].

- e. Spanning perpendicularly to the vaulted glulam frames and along the buildings longitudinal length are five (5) glulam beam sections including a single member that acts as the center ridge beam for the overall roof structure. The center ridge beam is braced by the vaulted glulam frames on each side using a standard single row nail pattern connection. The center ridge beam was measured to be approximately 9 inches in total depth and 5 inches in width. On either side of the ridge beam are two additional intermediate beam sections that make up the five (5) total roof supporting beam elements found throughout the roof structure. These beam elements are spaced evenly approximately 8 feet 4 inches on center along the roof area. Based on field measurements, they are approximately 13.375 inches in depth and 3 inches in total width. The intermediate glulam wood framing beam elements in combination with the vaulted glulam frames serve as the primary structural framing elements supporting the roof structure of the building [*Photographs 3-6*].
- f. Serving as the enclosing envelope for the roof area of the building structure is a combination of tongue and groove wood planks, various foam insulating materials, and roof sheathing. In cross-section the enclosing structurally insulated roof panel is comprised of the following components (in sequential order beginning at the exterior of the enclosing envelope): [*Photographs 7-8*]
 - Shingles (*Exterior*)
 - Layer(s) of Roof Sheathing
 - Insulated Foam Bead Board
 - Vapor Barrier Membrane
 - Tongue and Groove Wood Plank Boards
 - Two Layers of Foil-Faced Isocyanurate Insulation
 - Gypsum Board Paneling (*Interior*)

Discussion

The existing roof structure and its supporting framing elements were reviewed using the current Building Code loading standards specified within the Wisconsin Commercial Building Code which references both the ASCE 7-10 and the 2015 International Building Code. During the structural review various loading conditions were taken into consideration which includes the self-weight of the existing roof structure and its enclosing roof membrane, potential roof live load conditions, and design snow load events. Based on the occupancy type for the existing building structure the following design loads were used to perform a structural review that is in compliance with the current Building Code loading standards:

- Roof Live Load: 20 pounds per square foot (psf)
- Roof Snow Load: 32 pounds per square foot (psf)
- Roof Dead Load: 25 pounds per square foot (psf)

Using the design loads shown above a controlling load combination was determined and used within the structural review.

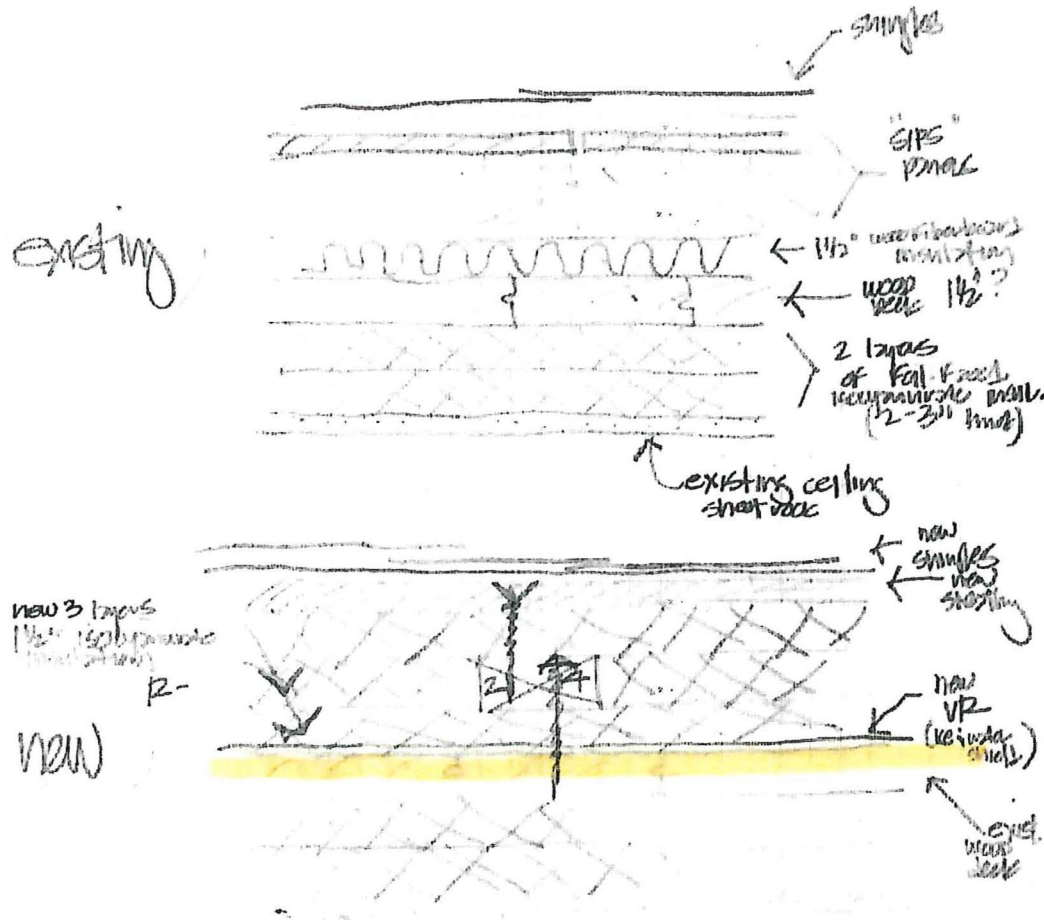
Based on field observations and client provided construction documents it appears that renovations and additions have been performed along the roof area of the building previously at some point in comparison to the original construction documents. The light fixtures are attached below the deck and within an area where warm air can transfer up into the SIPs panel system and cause condensation to build up and infiltrate back down through the interior enclosing ceiling system.

One of Braun Intertec's roofing consultant specialist's also reviewed the current conditions and issues exhibited throughout the roof area. Based on their review an alternative design option was proposed below and would consist of the following components:

- Remove the existing roofing materials down to the wood deck.
- Install a peel and stick vapor barrier and three (3) layers of 1 1/2" isocyanurate insulation with 2x4 wood framing nailers at 4 feet or 8 feet on center within the middle layer.
- Place a new single layer of roof sheathing, underlayment and roof shingles.

The three (3) layers of isocyanurate insulation would be necessary in order to meet the Building Code R-Value requirement and to get the dew point above the vapor retarder. Ultimately, without removing excess material along the roof area this type of alternative design solution to the existing roof membrane would impose additional permanent dead load to the overall building structure. See Figure 1 below for a concept sketch showing the existing conditions and the recommended modifications that involve removing excess materials throughout the exterior surfaces of the roof area.

Figure 1. Existing Condition and Concept Rehabilitation Sketch



Based on the structural review and given a worst-case design load event(s), we determined the internal bending stresses induced within the framing members are near their assumed maximum allowable design strength limit and do not have much reserve load-carrying capacity to supporting additional loads beyond those for which it was originally design for. With the limited amount of structural framing currently present along the roof structure and their associated span length, any additional load applied to that already in place would exponentially increase the total design load imposed on each structural framing element. Therefore, without providing additional structural reinforcement to serve as an alternative and/or redundant load path for the existing roof framing, any added permanent dead loads imposed on the roof structure would adversely affect the overall long-term structural performance and adequacy of the roof framing.

Improving the overall insulating performance of the existing roof envelope while still maintaining its structural adequacy and long-term integrity can only be achieved if the proposed alternative design solution incorporates the removal of excess roofing materials not needed from both a thermal and

structural standpoint. Shown below is a comparison identifying how the current as-built imposed dead loads throughout the roof structure are influenced through alternative design solutions that incorporate modifications to the existing envelope system.

Existing As-Built Condition:

- Shingles = 2 psf
- (2) 1
½" Roof Sheathing = 9 psf
- 1 ½" Rigid Insulation = 2.5 psf
- 1 ½" Wood Deck = 5 psf
- (2) 1 ½" Iso. Insulation = 1.0 psf
- Gypsum Board = 4 psf
- Total Roof Dead Load = 23.50 psf**

Proposed Design Solution: *Complete Removal of Excess Roof Material along Exterior*

- Shingles = 2 psf
- (1) 1 ½" Roof Sheathing = 4.5 psf
- (3) 1 ½" Iso. Insulation = 1.5 psf
- Wood Framing (2x4) = 1.0 psf
- 1 ½" Wood Deck = 5 psf
- (2) 1 ½" Iso. Insulation = 1.0 psf
- Gypsum Board = 4 psf
- Total Roof Dead Load = 19 psf**

Optimal Design Solution: *Complete Removal of Excess Roof Material along both Exterior and Interior*

- Shingles = 2 psf
- (1) 1 ½" Roof Sheathing = 4.5 psf
- (3) 1 ½" Iso. Insulation = 1.5 psf
- Wood Framing (2x4) = 1.0 psf
- 1 ½" Wood Deck = 5 psf
- Total Roof Dead Load = 14 psf**

The observations made throughout the visually accessible areas of the roof and building structure did not identify any obvious instabilities and/or life-safety concerns regarding the overall integrity of the building structure. A very limited amount of deteriorated and structurally fatigued conditions were identified during the assessment. From a visual standpoint alone the current condition of the building structure remains to be adequate in serving its intended purpose and continuing to sustain the imposed design loads for which it was originally designed for.

Conclusion

The existing structural framing members supporting the roofing are currently at or near their capacity based on our assumptions regarding both the true load-carrying capacity of the roof supporting structural framing elements as well as the assumed renovations done previously. It is recommended that the new roofing materials and insulation, intended to serve as a solution to the condensation buildup, not be placed along the existing roof structure without reducing the overall existing dead load by removing the existing roofing materials that are not needed as is indicated above. This will allow for the self-weight of the new roof membrane to be equal to or less than what is currently present.

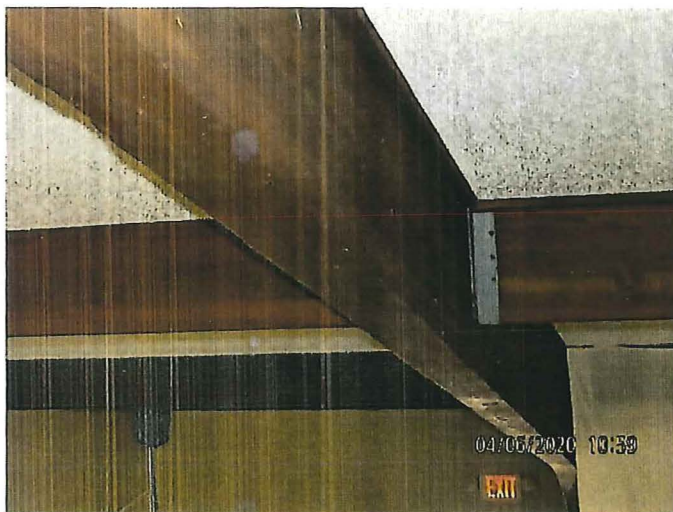

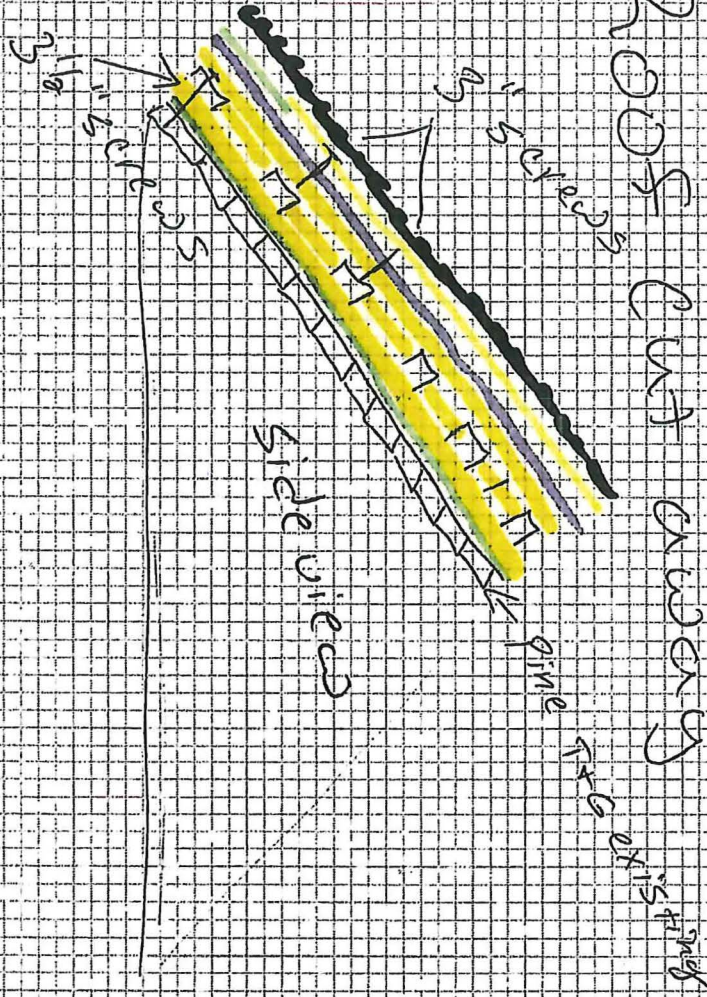

1) Meeting Convened

The Pierce County Building Committee met in the County Board Room of the Pierce County Courthouse, Ellsworth, WI. Chairman Dan Reis called the meeting to order at 4:49 p.m.

1a) Those Present

A quorum was established acknowledging 5 members present.

1b) Public Comment

Supervisor D. Auckland reported that he had received complaints about the condition of landscaping in front of Courthouse. Chairman D. Reis added he received a call as well. It was suggested that dead plants be removed for time being & fill area with rock.

2) Agenda Adopted

Motion by D. Auckland/M. Kahlow to amend agenda & move item #11 Livestock Committee Scale building to after #3; motion carried unanimously.

Motion by M. Kahlow/D. Auckland to adopt agenda as amended; motion carried unanimously.

3) Minutes Approved

Motion by J. Kosin/S. Bjork to approve minutes of the May 8th, 2018; motion carried unanimously.

11) Discuss/Take action on Livestock Committee Scale Building

Mr. Geraets explained that this group would like to replace the scale & put proposal together to replace it. He added that the Livestock Committee group would pay for cost to do so but likely not until 2019. Motion by M. Kahlow/S. Bjork to authorize a livestock scale building to be built on fairgrounds with cost to be funded by Livestock Committee; motion carried unanimously.

4) Discuss/Take action on Pierce County Fairgrounds Protest/Demonstration Policy

A. Webb explained that a circus was scheduled to use the fairgrounds this Sunday & that she received a letter from PETA discouraging the County from allowing this particular circus group to use the grounds. She indicated that there is a certain possibility that a group protest may take place. She also stated that Corp Counsel drafted a policy with regard to this type of activity & the group would need to consider adopting it so those rules could be in place. Motion by M. Kahlow/S. Bjork to approve Protest/Demonstration Policy as

presented; motion carried unanimously.

5) Discuss space needs

J. Forss indicated not much new to report but did assist in moving Human Services staff member to a different office.

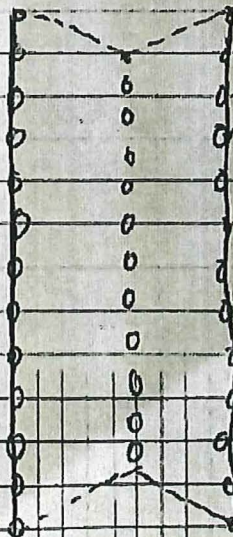
