3) Agenda Adopted

Motion by M. Kahlow/J. Kosin to adopt agenda as presented; motion carried/passed unanimously.

4) Public Comment

None.

5) Minutes Approved

Minutes of the Nov. 15, 2016 approved by motion of J. Kosin/M. Kahlow; K. Snow abstained.

6) Discuss space needs

AC J. Miller informed Committee that contract was finally completed & waiting for CB Chairman signature. She explained that the study would begin in February & completed by March 15th. Potter/Lawson would be on site to review previous space needs assessment & interview departments. She listed dates that the Committee would meet with the firm. No action taken.

7) Discuss/Take action on rental rates for Valley Springs Motorcycle to rent the grounds and Seyforth Building

Fair Coordinator A. Webb explained that the group was requesting to rent the grounds & Seyforth Building for a one day event in July. The fee would be \$381 for what they were asking. The group was requesting that the Committee waive the fee for camping at the Fairgrounds for individual campers. Committee discussed not wanting to set a precedent for this group, suggested instead of the group charging or collecting the fee that attendees be notified that if they are camping on the grounds they would be responsible for paying the camping fee of \$24/day. Motion by M. Kahlow/J. Kosin to approve rental to Valley Springs Motorcycle group at the rate of \$381 for one day & individual attendees wishing to camp on Fairgrounds be responsible for paying such fee; motion carried/passed unanimously.

8) Discuss/Take action on purchase of new snow shovels

Maintenance Supervisor J. Forss explained that the department was in need of many new shovels around the campus because they were old & deteriorating. Also that new railings would be installed & he suggested replacing metal shovels with a durable polyurethane type shovel. He added that he obtained three quotes for 18 shovels, the lowest being from River Falls Hardware. Motion by M. Kahlow/K. Snow to approve purchase of 18 shovels from River Falls Hardware in the amount of \$585.82; motion carried/passed unanimously.

9) Discuss water heater replacement in the Annex

Maintenance Supervisor J. Forss explained that one of the water heaters in the Annex was leaking substantially & the unit needed to be replaced before the meeting took place. Three quotes were obtained & the water heater was replaced with a commercial type heater at approx. \$12,000. He added that Focus on Energy was offering a \$400 rebate for this energy efficient unit & that Xcel Energy may offer an additional rebate. No action taken.

10) Maintenance Supervisor report

J. Forss submitted written report & was accepted by Committee.

11) Fair Groundskeeper report

M. Kelly submitted written report & was accepted by Committee. Chairman D. Reis asked Kelly about his recent attendance at the Fair Convention. M. Kelly indicated that he felt he learned more this year than last because he was more familiar with the whole process. He stated that he had attended several training sessions to include many of safety issues. Chairman D. Reis stated that after discussions with CB Chairman J. Holst & other supervisors that he would suggest that Mr. Kelly also attend Fair Committee meetings to address activities on the grounds or issues with equipment & buildings.

Pittman indicated that he would like to see a plan that forecasts out at least 5 years & where the Courts might be at that time. Supervisor N. Gulbranson stated that discussions about future Court facilities should take into consideration that Pierce County may add another Circuit Court Judge at some point in the not so distant future, thus the need for an additional courtroom. Supervisor M. Pittman asked when the study might be completed. E. Lawson responded saying that the intent would be to complete it by the end of March. Supervisor Pittman also asked if it would include the cost to remodel/remove the old jail portion of the Annex. Mr. Lawson indicated that could be addressed as an option. No action taken.

#6 – For years now there has been a contract between Pierce County and the Cottages of Ellsworth for the usage of the street lights along the Fairgrounds North entrance. Corp Council feels that the contract should be revisited seeing as it has been not looked at for a few years.

#8 – Betwixt the Courthouse, Annex and PCOB buildings, there are 12 restrooms that are handicap accessible. Of these 12 restrooms, 7 of them are set up to have more than one person in them at a time. The doors and their existing hardware of those 7 restrooms make them fairly easy to install the ADA Compliant door operators. The other 5 restrooms are 1 occupant at a time usage with locking door hardware which is not copasetic with the auto door openers. I had a door hardware end user consultant do a walk around with me to figure what items were needed for the 7 doors and he is also researching options to possibly add openers to them in the future.

I have 4 different quotes for the openers and other needed hardware.

1. TCH (Twin City Hardware)	\$26,639.38
2. KENDELL Doors & Hardware	\$26,971.00
3. WHC (Wheeler Hardware Comp.)	\$19,820.00
4. LAFORCE INC.	\$29,739.66
ALT. OPP.	\$28,939.66

Because Wheeler Hardware's quote was \$6,819.38 less than the next lowest quote, I made contact with them and their quote was for the same brand and model numbers that the other 3 bidders quoted. I have

Email documentation to back that up.

I would make the recommendation to go with the Wheeler Hardware Quote for \$19,820.00.

There are 2 line items in the 2017 Building Outlay labeled: Handicap Door Openers - \$26,000.00 and Handicap Door Openers -2016 \$8,095.00 to cover the cost of this project.

#9 – There has been different on Campus occasions where it would be very helpful to have a backhoe. \$3,000.00 was budgeted for a backhoe attachment to go on the fairs tractor. Talking with Matt after the budgeting was done, the 2 of us decided that an upgrade from the stiff armed attachment as budgeted to one that swiveled to the sides would be a huge time saver. This attachment would also fit our Utility Vehicle and could be used other places on Campus other than just in the fairgrounds. There is \$9,866.00 left in the Building Outlay from last year's budget that the difference between the \$3,000 and the low bid of \$4,100.00 could come from. Please see the attached materials for the quotes.

#10 – In the past years 2 five row metal bleachers have been bought to replace 2 five wooden bleachers. This year and going forward buying 1 ten row metal bleacher to replace 2 of the old wooden bleachers is what Matt would like to do. There are events that the taller bleachers would allow more spectators. 1 ten row can be bought for about the same dollars as 2 five row bleachers. Please see the attached materials for the quotes.

#11 – The fair uses a golf cart to travel their grounds but at times one is not enough. Please see the attached materials for the quotes.

#12 - Please see the attached materials for the quotes for the bagger attachment.

#15 – Matt and his crew have been doing a lot of different building and concrete projects since he has taken over and he feels that a laser level and a power screed would be well worth the purchase for not only saving time on the projects but completing them with better accuracy. These 2 items would get funded from the fairs 2017 tool budget. Please see the attached materials for the quotes.

#16 – As you can see by driving by the Fairgrounds that there is a lot of its perimeter fence this is in ill repute. Many parts of it the fence is holding up the post. At 2017 budget time in total there was approximately 4168' of fence. Since then approximately 700' feet, the section behind the carwash and post office, was permanently removed. It was elected to at budget time to only replace 608' feet of it in 2017. This year's planned replacement section is the fence is on the North and East sides of the fairgrounds that starts by the Boy Scout building and goes around to the East entrance gate. Please see the attached materials for the quotes.

#17 – There is a plethora of cement traffic barriers that are strategically placed in the track area of the grandstands to help keep spectators and participants safe during different events during the fair. These barriers weigh about 2 ½ tons apiece and aren't the easiest things to move. There is a row that gets put in on the South side of the track that was nicely placed and leveled by the fair staff along with a couple other

areas that according to Matt that there is no reason for them to be moved once placed. Other people that use the track area for events think they need to move them and not put them back. It would be nice to have an official rule in place that says the fairgrounds keeper has the ruling on their placement and if others move them, they will be held accountable for the moving of them buy a forfeiture of funds or asked not to return.

#18 - Matt wanted the Building Committee to know that the Funsters are in the process of putting together some plans and ideas for a clubhouse type building to be placed at the west end of the grandstands.

**CONTRACT BETWEEN PIERCE COUNTY AND NOEL and PAULA TOTTE
d/b/a COTTAGES OF ELLSWORTH FOR USAGE OF STREET LIGHTS**

This contract by and between Pierce County, a Quasi-Municipal Corporation, Ellsworth, Wisconsin, and Noel & Paula Totten, individuals, (hereinafter "Tottens") doing business as Cottages of Ellsworth.

WHEREAS, Pierce County (hereinafter "County") owns street lights located on the Pierce County Fairgrounds, near the North Gate Entrance, in Ellsworth, Wisconsin; and

WHEREAS, Tottens own property adjacent to the Pierce County Fairgrounds and the residents of the Cottages of Ellsworth have requested the use of the lights from dusk to dawn; and

WHEREAS, the County has no objection to leaving the lights on for use by residents as long as Tottens pay for the usage and the County is held harmless from any liability arising out of use and/or maintenance of said lights.

NOW THEREFORE, THIS AGREEMENT:

I. PURPOSE OF AGREEMENT

The purpose of this agreement is to provide use of the lights owned by the County to residents/tenants of the Cottages of Ellsworth at no cost or liability to the County. The lights referred to are those located directly east of the Cottages, referred to as the North Gate Entrance, not including the northern most light which is maintained by the City of Ellsworth.

II. TERM OF AGREEMENT

The Contract shall be effective January 1, 2017 to December 31, 2017, notwithstanding the date of execution herein. Tottens understand and acknowledge that this is a one year agreement only. The County reserves the right not to extend this agreement beyond the end of that term, whether on the same or any other terms and conditions. Tottens have no expectation that this agreement will extend beyond the one year term set forth therein.

III. CONSIDERATION

The determined cost to leave the three lights on, from dusk to dawn each day, for twelve months is \$540, due within 30 days. The lights will be turned on upon receipt of payment in the Fair Office, on or as close to January 1, 2017 as possible. If it is determined on or before December 31, 2017 that the cost of leaving the above mentioned lights on is greater than \$540, the County has the right to request and receive payment of the additional charges from Tottens within 30 days of the County mailing a statement of additional costs or no later than February 1, 2018.

IV. MODIFICATION

No changes or modifications shall be made to the terms of this contract unless it is to the mutual satisfaction of the parties, made in writing and signed by representatives of the parties.

V. RESERVATION BY COUNTY TO RESCIND AGREEMENT

The County reserves the right to cancel this agreement at any time upon 5 days written notice to Tottens. No cause need to be stated by the County for said cancellation. Should the County choose to exercise its right to cancel under this provision, it shall be responsible to refund to Tottens a pro rata portion of the amount paid for the usage.

VI. HOLD HARMLESS

Tottens shall notify the County in a timely manner, through the Fair Office, of any lights that have been burned out and in need replacement or repair. The County will repair and maintain the lights on its property. Tottens agree to indemnify and hold the County harmless for any personal injuries or property damage caused by a failure to provide the lights as agreed herein.
